#### 3. GENERAL PUBLIC COMMENTS

Natalie Peterson stated that the City of Vallejo was opening Warming Centers Friday and Saturday nights, March 27 - 28, 2023, and requested other cities to open their own centers if they had the ability because people were traveling from other cities to get to Vallejo.

John Eckstrom apologized for his comments at the prior meeting regarding deaths at SHELTER Solano and that he has talked to the family members who spoke at the February meeting. In addition, he is addressing the reporting processes of any future passings at SHELTER Inc.

Tim Williams spoke about the importance of keeping the faith based community and the church as part of the process of helping the homeless population.

Jared Neumayr spoke about the issues that businesses are having with the homeless population and the impact on commerce in the city and stated that as the President of the Fairfield-Suisun Chamber of Commerce, he wanted to make sure the JPA knew the Chamber of Commerce wanted to be involved.

Chair Mashburn stated that the Board of Supervisors reconvened to finalize the approval of the ARPA funding. In addition to providing funding to the City of Vallejo's Permanent Supportive Housing, SHELTER Solano Navigation Center, and the Transition Age Youth housing as discussed at the previous Board of Supervisor's Meeting, the Board unanimously to provide funding to the City of Vallejo's Navigation Center, funding for NorthBay Healthcare, and some for agriculture as well. Chair Mashburn also stated that a

few proposals were withdrawn and that if all went well this would conclude the process of allocations for Solano County's ARPA funding.

Reneé Parham gave an overview of the 2022 Annual Report and Infographics found in the <u>public folder</u>. Mayor Hernandez made a motion to accept the Annual Report. Chair Mashburn seconded the motion. There were no abstentions or objections. The motion was approved.

d. Provide input into the CAP Solano Strategic Planning Agenda – DISCUSSION

Kelly Shaban led a conversation capturing Board Members input for the Solano Strategic Planning Sessions which included insight into what they hope to learn and achieve during the sessions. Board Members shared goals of discussion around the vision and mission of the JPA, administrative structure, regional policies, and project priorities.

Mayor Hernandez thanked Megan Richards and Homebase for their assistance in extending the Community Needs Assessment until after the Suisun City Homeless Outreach Event that was going to take place April 5, 2023 at the Joseph Nelson Center.
